Aftercare club fees:

Registration fee: R150.00 (New learners only)

R450 per month for 11 months (Jan-Nov)



LA Aftercare Club Contract:

Childcare will be provided by at the school, during the agreed times on the agreed dates, which is Mondays from 14:00 to 17:00 and Fridays from 13:00 to 17:00. Note that Aftercare times are subjectable to changes, according to school events and times. Assistance with homework and/or study sessions will be provided (excluding tasks and speeches). **Please note this is not a substitute for extra classes.**

The childcare provider will strive to provide a safe and secure environment for your child but cannot guarantee that the playground will be accident free. In the unfortunate event of an accident, first aid will be administered, and parents will be notified immediately. See attached indemnity form.

The parents/guardians of a child in the LA Aftercare Club will:

- Provide lunch, snacks, and drinks according to their child's preference and needs.
- Provide us with any information relating to your child and complete all documentation as requested.
- Notify us of any medical or physical needs that your child has.
- Provide us with your correct and up to date contact details.
- Keep us informed of any matters that are relevant to your child's safety and security.
- Keep us informed of the identity of those persons who are authorised to collect your child from the afterschool club. If an identification and consent cannot be provided, the child will not be released from the school.
- Inform us timeously if you are unable to collect your child at 17:00 (A late fee of R50 per 15 minutes will be charged).
- Inform us if your child will not attend the Aftercare Club.
- Adhere to prompt payment of the aftercare fees.

Payment of the LA Aftercare Club fees:

- Registration fee R150.00, payable upon registration. (new learners only)
- Monthly fee of R450.00, payable in advance.
- Late collections will be charged at R50.00 after closing time (17:00) per 15 minutes.
- **In the event of non-payment, your child will be removed from the Aftercare Club and a penalty admin fee of R150-00 and all outstanding fees will have to be paid before your child is accepted back.**
- Payments will be monitored strictly.

Cancellation:

- You may terminate the Aftercare Club services at any time as long as fees are paid up to date.
- The Aftercare Club may immediately terminate services if you fail to pay fees that are due.
- The Aftercare Club may terminate services if the child behaves inappropriately or unacceptably towards staff and/or other aftercare children. (physical or verbal abuse)
- The Aftercare Club may immediately terminate services if you have breached any of your obligations under this agreement.
- The Aftercare Club may immediately terminate services if you collect your child late on a regular basis.
- The Aftercare Club may terminate services if a parent was given a warning about said child's behaviour more than twice.

CONSENT, INDEMNITY AND WAIVER

acting in my personal capacity and in my capacity as the parent/ legal guardian of:

_____ (hereinafter referred to as 'The Participant'), who is to be enrolled and participate in the AFTERCARE care centre (hereinafter referred to as 'LA Aftercare Club') which is to be conducted in the buildings of Lowveld Academy Private Primary School, but completely independent therefrom as the centre organiser as hereinafter defined may in her sole discretion decide too hereby:

1.1 Certify that all the information contained in these forms is true and correct and that no material information whatsoever has been withheld.

1.2 Undertake on my own behalf and on behalf of the Participant to abide by all the rules, regulations and procedures of the Centre, with which rules regulations and procedures I acknowledge myself to be acquainted.

1.3 Undertake to pay all amounts payable in connection with the Participant's participation in the Centre.

1.4 Irrevocably indemnify, on my own behalf and on behalf of the Participant, the Centre Organisers (including all Centre staff who may be teachers at Lowveld Academy Private Primary School or elsewhere who are to be employed at the Centre in a part-time capacity), as well as Lowveld Academy Private Primary School (including its staff), or any person acting on their behalf, or any of its affiliated or constituent bodies and directorates and/ or any representative, employee, servant or agent of any of the afore going bodies or persons, against any claim whatsoever which may be made against them and/or liability which may be incurred by them and/or any damage which may be suffered by them.

1.5 Undertake on my behalf and on behalf of the Participant, jointly and severally, that such claim and/or liability will be paid by me and/or the Participant to the Centre Organisers or any of the bodies/persons called upon to make payment.

1.6 Acting on my own behalf and on behalf of the Participant, jointly and severally, absolve the Centre Organisers from any liability whatsoever and howsoever caused for any loss, injury or damage which may be caused to the person or property of the Participant and agree that neither I nor the Participant shall have any claim of any nature whatsoever against the Centre Organisers or any of bodies (referred to herein) in such event.

1.7 Acting on my own behalf and on behalf of the Participant, waive all or any claims that I or the Participant may have against the Centre organisers or any of the said bodies in respect of any loss, damage or injury to the person or property of the Participant which may be sustained by the Participant during the conveyance of the Participant by whatever mode of transport.

1.8 Acting on my behalf and on behalf of the participant, jointly and severally, designate the Centre Director or anyone appointed by the Centre Director to act in *loco parentis* on my behalf during the course of conducting the Centre, in particular but without derogating from the generality of the afore going, he Centre Director of the appointee of the Centre Director shall in his/her sole discretion have the authority to give permission for any emergency operation or medical treatment for the Participant and to incur on my behalf all expenses flowing therefrom, which I undertake to repay on demand.

1.9 Accept on behalf of the Participant that, in the event of the Participant being unable for any reason whatsoever to attend or participate in the Centre for the full period or at all, neither the Participant nor I shall have any claim for refund of any fees already paid to the Centre.

1.10 Acknowledge, on my behalf and on behalf of the Participant, that each of the afore going provisions is separable from the other of them and may be enforced against us or either of us, separate from the other provisions.
